**OVERSIGHT**: Providing oversight for pastoral excellence by creating and offering professional development opportunities for all authorized ministers in required areas of Healthy Practices for Ministry, as well as assisting with ministry issues when asked.

- Provided a Situational Support Consultation for a congregation and recommended mediation. A mediator was then provided.
- Continued to address boundary issues involving retired clergy and their former congregations.
- Restored the full standing of an authorized minister who had been on an extended leave of absence.
- Revamped our approach to diversity training with a Healthy Practices event on "Cultural Humility" led by The Rev. Dr. James Knight (10/18/23). This program was well attended, enthusiastically received, and will be offered again in the spring of 2024. Other Healthy Practices offerings under consideration include: Handling Criticism, and Successful Post-Pandemic Ministry.
- Reviewed the situations of a few congregations that were closing/consolidating.
- Appointed a resource team to assist with any issues within local congregations that might arise during Nayiri's sabbatical.
