Reports from Working Groups

- Credentialing ask for recent sermon from interviewees; remind about what can be cited for continuing education; considering requesting licensed ministers to tell us who they might like as a mentor (think that everyone should have one); workshop on the Marks for Licensed Ministers in the fall
- Discernment finalizing MID discernment plan; meeting people and helping them in the process of preparing for ordination
- Oversight Healthy Practices: 5 May Hybrid Worship; Oct Ethics & Boundaries; conversations around ongoing concerns, ethics for departing pastors

Discussion about MINISTERIAL FORMATION PLAN FOR ORDAINED MINISTRY Document [see also red print in document, attached] – consensus to move forward with this document

- Looking for language to explain the options for the process toward ordination
- If someone seeking Privilege of Call with the Credentialing WG would this be useful there? – not a standing, but a 1-year status process, still required to meet the requirements of the body who holds your original standing
- Trying to objectify the subjective, but still need to find a way of evaluation of the system as well as of the MIDs
- Endorsement of the Plan is with the WG, not the WC
- Discussion around concern about sources of education for people preparing to serve UCC congregations
 - May be different for different congregations (small/large; conservative/progressive, etc.)
- Sometimes may emphasize what is *required* regardless of what a MID/congregation desires
- God/Holy Spirit is part of the process along with the MID and CoM/WG
- Discernment of call is a community process, not only individual; request for Discernment comes from the local church
- A list of approved educational sources will be provided possibly have at least 1 alumni contact for each
- It is the responsibility of the (potential) MID to initiate all contacts
- In specific/exceptional circumstances, the CoM/WG may depart from this document – need to express this clearly somewhere in the document (may be somewhere – but need to include it on this iteration)
