How the relationships and activities of our congregation extend outward in service and advocacy.

We open our doors, both physically and virtually, to serve identified community and country-wide needs, such as:

- Scouts of America
- AA
- Produce give away
- Ice cream following the Memorial Day parade
- Film crews creating faith based films
- Working with JFS to aid those in need of financial assistance for gasoline and electricity, etc.
- A very active Prayer Chain
- Evening prayers and a chance to check up on our neighbors, both locally and across the country.

We also have begun to serve a homeless population, in conjunction with the North Presbyterian Church, in Cleveland's inner city, by providing dinner following a morning worship service. 3 lay people who take turns to fill the pulpit when the current pastor is on vacation, ill, or otherwise not available. They cover both churches in the same timing and manner as the current pastor does, composing the bulletin, delivering the sermon, prayers, and responsive readings, selecting the hymns, and serving communion, if it falls on a communion Sunday, etc.

Newbury United Community Church is small (20 in worship), aging - but with some occasional younger attendees who bring new energy and children into the mix. During my time they firmed up their budget and are spending within their limits, along with surviving various times of closure during COVID, and completed some projects to keep their building in good shape. They are aware, and have some measure of desire to begin to reach into the community to ascertain needs that they could begin to address with the love of Christ and make a difference in people's lives. However, I was unable to move them forward in any specific endeavor.

This will be the challenge for their next pastor. There is some energy to move forward. The challenge is they are a small group, and not all are able to physically carry this out.

Their relationship with the Burton church is solid, and may be useful moving forward.
